

# Early Education and Childcare Local Authority Funding Agreement

1st September 2021 to 31st August 2022

---

This section of the Agreement derives from the [Model Agreement](#) issued by the Department for Education (DfE). The content has been set by the department for which all local authorities must include as part of a provider agreement to deliver the free entitlements.

Alongside the agreement content includes links to where further information can be found.

This document does not provide guidance on how providers operate their private businesses, including charges for the provision over and above a child's free hours.

The Local Authority will not intervene where parents choose to purchase additional hours of provision or additional services **providing** that this does not affect the parent's ability to take up their child's free place.

This agreement will be kept under review and updated as necessary.

It is not intended to replace, supersede or negate the requirements or expectations set out in legislation, other published statutory guidance and government advice.

The Local Authority cannot impose requirements which subject the quality of the early years provision, or services provided by the childminder agency, to a quality assessment process by the local authority; or require the provider to attend any training or other quality improvement programme, other than any training or quality improvement programme identified in an early years provision inspection report.

When signing the agreement documentation (Part A), the provider is agreeing to or understand the following –

- A right to unilaterally vary the agreement to reflect changes in legislation and departmental guidance
- A clause stating that references to legislation will be to that legislation as amended from time to time, without express change in the model agreement and/or provider agreement
- Freedom of Information provisions
- Termination and enforcement clauses, to cover all enforcement stages up to and including termination of the agreement. The local authority should also make clear that they do not waive the right to act if they do not act immediately (a slower evidence based approach may be required on occasion)
- An obligation to comply with all relevant legislation
- Provisions for dealing with data protection and confidentiality
- An obligation to take out and maintain adequate levels of insurance
- Provisions dealing with how funding must be accounted for and recorded for audit purposes
- A clear process for resolving any disputes

2.5	The local authority should work in partnership with providers to agree how to deliver free entitlement places.	
2.6	The local authority should be clear about their role and the support on offer locally to meet the needs of children with special educational needs and/or disabilities (SEND) as well as their expectations of providers.	
2.7	The local authority must contribute to the safeguarding and promote the welfare of children and young people in their area.	
<b>Key provider responsibilities</b>		
2.8	The provider must comply with all relevant legislation and insurance requirements.	<ul style="list-style-type: none"> <li>• Early Years Foundation Stage</li> <li>• Early Education Funding Toolkit</li> <li>• SEND Code of Practice</li> <li>• SEND Funding Sources</li> </ul>
2.9	The provider should deliver the free entitlements consistently to all parents, whether in receipt of 15 or 30 hours and regardless of whether they opt to pay for optional services or consumables. This means that the provider should be clear and communicate to parents details about the days and times that they offer free places, along with their services and charges. Those children accessing the free entitlements should receive the same quality and access to provision.	
2.10	The provider must follow the EYFS and have clear safeguarding policies and procedures in place that link to the local authority's guidance for recognising, responding, reporting and recording suspected or actual abuse.	
2.11	The provider must have arrangements in place to support children with special educational needs and/or disabilities (SEND). These arrangements should include a clear approach to identifying and responding to SEND. Providers should utilise the SEN inclusion fund and Disability Access Fund to deliver effective support, whilst making information available about their SEND offer to parents.	
<b>Safeguarding</b>		
2.12	The local authority has overarching responsibility for safeguarding and promoting the welfare of all children and young people in their area. They have a number of statutory functions under the 1989 and 2004 Children Acts which make this clear, and the 'Working together to safeguard children' 2015 guidance <sup>1</sup> sets these out in detail.	<ul style="list-style-type: none"> <li>• Safeguarding</li> <li>• Early Years Foundation Stage</li> <li>• Working Together to safeguard Children 2015 Guidance</li> </ul>
2.13	The provider must follow the EYFS and have clear safeguarding policies and procedures in place that are in line with local guidance and procedures for responding to and reporting suspected or actual abuse and neglect. A lead practitioner must take responsibility for safeguarding and all staff must have training to identify signs of abuse and neglect. The provider must have regard to 'Working Together to safeguard Children' 2015 guidance.	
<b>Eligibility</b>		
2.14	The provider should check original copies of documentation to confirm a child has reached the eligible age on initial registration for all free entitlements. The provider can retain paper or digital copies of documentation to enable the local authority to carry out audits and fraud investigations. 2.15	The provider should offer places to eligible two-year-olds on the understanding that the child remains eligible until they become eligible for the universal entitlement for three- and four-year-olds.	
2.16	The local authority must ensure that a child has a free entitlement place no later than the beginning of the term following the child and the parent meeting the eligibility criteria for the free entitlements.	
2.17	Alongside the 30 hours eligibility code, which is the child's unique 11-digit number, and original copies of documentation (see 2.14), a provider must acquire written consent from, or on behalf of, the parent to be able to receive confirmation and future notifications from the local authority of the validity of the parent's 30 hours eligibility code.	
2.18	Once a provider has received written consent from the parent, they should verify the 30 hours eligibility code with the local authority.	
2.19	The local authority will confirm the validity of 30 hours eligibility codes to allow providers to offer 30 hours places for eligible three- and four-year-olds. The local authority will provide a validity checking service to providers to

The Eligibility Checking Service (ECS) allows all local authorities to make instant checks for code validity.</p> <p>Thereafter, the local authority should complete audit checks to review the validity of eligibility codes for children who qualify for 30 hours free childcare at 6 fixed points in the year, both at half-term and at the end of term across the year (in line with the dates as listed at table A below). <b>Partnership working</b>

<b>Special educational needs and disabilities</b>		
2.32	The local authority must strategically plan support for children with special educational needs and/or disabilities (SEND) to meet the needs of all children in their local area as per the Special Educational Needs and Disability code of practice: 0 to 25 years <sup>3</sup> (January 2015).	<ul style="list-style-type: none"> <li>• SEND Code of Practice</li> <li>• Norfolk's Local Offer</li> </ul>
2.33	The provider must ensure owners and all staff members are aware of their duties in relation to the SEND Code of Practice and the Equality Act 2010.	
2.34	The local authority must be clear and transparent about the support on offer in their area, through their Local Offer, so parents and providers can access that support.	
2.35	The provider should be clear and transparent about the SEND support on offer at their setting and make information available about their offer to support parents to choose the right setting for their child with SEND.	
<b>Social mobility and disadvantage</b>

<b>Quality</b>		
2.38	The Early Years Foundation Stage (EYFS) statutory framework is mandatory for all schools that provide early years provision and Ofsted-registered early years providers in England. 2.39	Ofsted are the sole arbiter of quality for all free entitlements and Ofsted and inspectorates of independent schools have regard to the EYFS in carrying out inspections and report on the quality and standards of provision.	
2.40	Local authorities have a legal duty to provide information, advice and training on meeting the requirements of the EYFS, meeting the needs of children with SEND and on effective safeguarding and child protection for providers who are rated less than 'Good' by Ofsted or newly registered providers.	
2.41	Provision must be offered in accordance with the national parameters on quality as set out in Section A3 of Early Education and Childcare Statutory Guidance for Local Authorities and the EYFS statutory framework.	
<b>Business planning</b>

2.43	The local authority should not charge providers disproportionate penalties for providing late or incomplete information leading to additional administration in the processing of free entitlements. Any charges should be reasonable and proportionate to the inconvenience or costs incurred to the local authority as a result of the lateness and local authorities will ensure charges are clearly communicated to providers.	
2.44	The local authority should not carry out audit regimes which are disproportionate or are unnecessarily burdensome to providers.	
2.45	The provider should ensure they submit timely and accurate information, including, but not limited to, headcount data, census data, parental declarations and invoices, as per the financial guidelines of their local authority. Failure to do so may result in inaccurate, delayed or suspended funding.	
2.46	The provider should maintain accurate financial and non-financial records relating to free entitlement places and should give the local authority access on reasonable notice to all financial and non-financial records relating to free entitlement places funded under the provider agreement, subject to confidentiality restrictions.	
<b>Charging</b>		
2.47	Government funding is intended to cover the cost to deliver 15 or 30 hours a week of free, high quality, flexible childcare. 2.49	The provider can charge for meals and snacks as part of a free entitlement place and they can also charge for consumables such as nappies or sun cream and for services such as trips and musical tuition. Parents should therefore expect to pay for these, although these charges must be voluntary for the parent. Where parents are unable or unwilling to pay for meals and consumables, providers who choose to offer the free entitlements are responsible for setting their own policy on how to respond, with options including waiving or reducing the cost of meals and snacks or allowing parents to supply their own meals. 2.50	The provider should deliver the free entitlements consistently so that all children accessing any of the free entitlements will receive the same quality and access to provision, regardless of whether they opt to pay for optional hours, services, meals or consumables.	
2.51	The local authority should not intervene where parents choose to purchase additional hours of provision or additional services, providing that this does not affect the parent's ability to take up their child's free place. The provider should be completely transparent about any additional charges.	
2.52	The provider should publish their admissions criteria and ensure parents understand which hours/sessions can be taken as free provision. Not all providers will be able to offer fully flexible places, but providers should work with parents to ensure that as far as possible the pattern of hours are convenient for parents' working hours.	
2.53	The provider can charge parents a deposit to secure their child's free place but should refund the deposit in full to parents within a reasonable time scale.	
2.54	The provider cannot charge parents "top-up" fees (any difference between a provider's normal charge to parents and the funding they receive from the local authority to deliver free places) or require parents to pay a registration fee as a condition of taking up their child's free place.	
2.54	The provider should ensure their invoices and receipts are clear, transparent and itemised, allowing parents to see that they have received their free entitlement completely free of charge and understand fees paid for additional hours. The provider will also ensure that receipts contain their full details so that they can be identified as coming from a specific provider.	
<b>Funding</b>		
2.55	The local authority should pay all providers, particularly childminders, monthly by September 2018 unless a provider requests and the local authority agrees to continue an existing alternative sustainable method of payment.	<ul style="list-style-type: none"> <li>• Provider Portal Guidance</li> <li>• Early Education Funding Toolkit</li> </ul>
2.56	The provider should accurately complete and submit headcount and other necessary data returns by the agreed date to support the local authority to make payment.	
2.57	Local authority to set out funding process and timetable so providers are clear about the funding that they will receive and the requirements on them in order to receive it, including funding multiple providers and changes in provider.	
<b>Compliance</b>

2.59	The local authority should set out details of their compliance process in this section.	
<b>Termination and withdrawal of funding</b>		
2.60	Suspension of registration by Ofsted or a breach of statutory requirements or safeguarding issues may result in the termination of the arrangement and withdrawal of funding.	<ul style="list-style-type: none"> <li>• Early Education Funding Toolkit</li> </ul>
2.61	The Local Authority should insert details of their termination/withdrawal of funding terms and process. Termination provisions must also include those required by regulation 7 (Termination of the arrangements) of the Local Authority, (Duty to Secure Early Years Provision Free of Charge) Regulations 2014 and regulation 37 (Arrangements between local authorities and early years providers: termination) of The Childcare (Early Years Provision Free of Charge) (Extended Entitlement) Regulations 2016]	
<b>Appeals process</b>

<b>Complaints process</b>		
2.64	The local authority should set out here their complaints procedure for parents who are not able to resolve their concern directly with the provider where the parent is not satisfied that their child has received their free entitlement in accordance with the legislation or as set out in this agreement and in Early Education and Childcare Statutory guidance for local authorities. 2.65	The Provider should ensure they have a complaints procedure in place that is published and accessible for parents who are not satisfied their child has received their free entitlement in the correct way, as set out in this agreement and in Early Education and Childcare Statutory guidance for Local Authorities.	
2.66	If a parent or provider is not satisfied with the way in which their complaint has been dealt with by the local authority or believes the local authority has acted unreasonably, they can make a complaint to the Local Authority Ombudsman. Such complaints will only be considered when the local complaints procedures have been exhausted
